

<b>FACTS</b>	WHAT DOES <b>CU Home Mortgage Solutions, LLC</b> DO WITH YOUR PERSONAL INFORMATION?
<b>Why ?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. <b>Please read this notice carefully to understand what we do.</b>
<b>What ?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>* <b>Social Security Number</b></li> <li>* <b>Credit History</b></li> <li>* <b>Employment Information</b></li> <li>* <b>Assets</b></li> <li>* <b>Credit Scores</b></li> <li>* <b>Income</b></li> </ul>
<b>How ?</b>	All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons <b>CU Home Mortgage Solutions, LLC</b> chooses to share; and whether you can limit this sharing.

What we do	
How does <b>CUHMS</b> protect my personal information?	To protect your personal information from unauthorized access and just, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does <b>CUHMS</b> collect my personal information?	We collect your personal information, for example, when you: <ul style="list-style-type: none"> <li>* Apply for a loan</li> <li>* Give us your contact information</li> <li>* Give us income information</li> <li>* Provide employment information</li> <li>* Provide your mortgage information</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit sharing to: <ul style="list-style-type: none"> <li>* Sharing for affiliates' everyday business purposes-information about your credit worthiness</li> <li>* Affiliates from using your information to market to you</li> <li>* Sharing for non-affiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for a joint account?	<b>Your choices will apply to every person on the account - unless you tell us otherwise.</b>
Definitions	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial or nonfinancial companies. <i>Our affiliates include financial companies such as:</i> <ul style="list-style-type: none"> <li>* Verity Credit Union</li> <li>* Harborstone Credit Union</li> </ul>
<b>Non-affiliates</b>	Companies not related by common ownership or control. They can be financial or nonfinancial companies.
<b>Joint Marketing</b>	A formal agreement between non-affiliated financial companies that together market financial products or services to you.
